Parents/Guardians shall pay childcare fees based on the rates specified below. Childcare fees will not be adjusted for late arrival, early pickup, or missed days.

1. Full-Time **Preschool** Childcare Fees: Childcare fee for Full-Time prescheduled childcare is \$1600 per month for potty trained students and \$2000 for diapering students.
2. Full-Time **Infant/Toddler** Childcare Fees: Childcare fee for Full-Time prescheduled childcare is \$2300 per month for potty trained students and diapering students.
3. Part-Time **Preschool** Childcare Fees: Childcare fee for Part-Time prescheduled childcare is \$1600 per month for potty trained students and \$2000 for diapering students. Part-Time childcare is up to 5 days per week.
4. Full-Time Extended Childcare Fees (only offered for preschool and afterschool age): Childcare fee for Full-Time Afterschool prescheduled childcare is \$500 per month.

Timing and Method of Payment:

Parents/Guardians shall pay childcare fees on or before the first of each month. In addition, if fees are not paid in full and on time, parents/guardians agree to pay a \$50 late fee. If fees are not paid within 10 days, the child(ren) will not be allowed to attend the facility until payment is received in full.

Parents/Guardians agree to pay a \$50 fee for all checks returned unpaid. After the second check is returned unpaid, all future payments shall be made in cash. Payments may be made by cash, check, or automatic draft.

All tuition paid is nonrefundable. *If your child is withdrawn from our program while a balance remains on their account, he/she cannot return until the balance has been paid in full.

Registration Fee: Parents/Guardians shall pay \$250 per child as an annual registration fee when this contract is signed. The registration fee is nonrefundable and is applied to the materials costs.

Late Pick-Up Fees Parents/Guardians agree to pay \$1.00 for each minute after closing until 3:30 P.M. or until pickup. This overtime fee shall be paid with the next scheduled payment.

Termination of Childcare:

Childcare may be terminated by the parent/guardian only by providing the childcare with two months advance written notice. Madeline depends on your student's enrollment to adequately provide for her family.

Wildflower Outdoor Learning Center retains the right to terminate this contract without notice for the following reasons:

- The child(ren)'s behavior is destructive, uncontrollable, violent, or threatening to the other children or providers at the care facility. This determination is made at the sole discretion of the provider.
- A parent's/guardian's behavior is threatening or abusive to the other children or providers at the care facility.
- Childcare fees are two weeks or more delinquent. All terminations of this type can be made effective immediately.

Modification of Terms:

Wildflower Outdoor Learning Center shall be entitled to change any of the terms in this contract, including but not limited to fees, by providing the parents/guardians with 30 days advance written notice of such changes.

Break Fees:

At any point during the year that schools take a week (or more) long break, the parents/guardians are required to pay the full fee for their child(ren). This includes, but not limited to, Spring Break, Thanksgiving Break, Christmas Break, and Summer Break. Parents of children who are considered full-time or part-time will pay \$1600 a month for potty trained preschool students, \$2000 for diapering preschool students, and \$2300 for infants/toddlers during the month with a break.

Tuition Agreement:

I agree to pay \$1600 (potty trained preschoolers) a month or \$2000 (diapering preschoolers) a month or \$2300 (infants/toddlers) for my child(ren)'s monthly tuition for _____
(Part-Time/Full-Time) care.

By signing this contract, the undersigned represents that the undersigned has understood and agreed to the terms and conditions of this contract. Breach of this contract in any way by the parents/guardians may result in immediate termination of childcare services.
